OK Hmong New Year Sport Rules and Regulations

This sports rules and regulations are to assist in the provision of the quality sport experiences for both the players and viewers. It will encourage the safety and enjoyment of the sport to everyone whom are involved in the event. The following requirements apply all players in order to ensure everyone's safety.

This policy will be reviewed annually by HMAAO's Board of Directors and Executive Directors to ensure that it remains relevant to the sports rules and meet community expectations.

All players will play by the rules and regulation set by Hmong American Association of Oklahoma, Inc.

It is imperative that all the coaches, team managers, team captains, and players are familiar and understand the rules and regulations established by HMAAO of the sport that he/she will play in this tournament.

All team captains **must** fill out the sports form (*Sport rules & Regulations and Sport Registration form*), list all the players' names and sign the forms.

All participating athletes can only participate on one team of the same sport.

Games' Rules:

1. All team must report to the field 30 minutes prior to the start of the tournament and 15 minutes prior to the start of each game. Failure to be present at the field will be postpone to next game or cancel.
2. Upon the referee starting the match, any team that does not show up or does not have enough players as stated by the Rules and Regulations will be deemed as the loser of that match. For soccer there must be a minimum of 7 players on the field to be considered a full team. For Tuj Lub, any team with less than 4 players will be deemed as the loser of that match.
3. Team participating "must" have uniform (or at least shirt uniforms) to play. No exception!
4. In the event of severe/dangerous weather or the other circumstances, Sport Committee of HMAAO shall determine the continuation or the outcome of the game/tournament.
5. The Event Committee of HMAAO will not refund any registration or application fee for any reason once the game has started. Refund may be given to a team if they cannot play. If any team is disqualified for any reason or refuse to play, no prize will be award to that team.
6. Any player under 18 years old must have parents' permission prior to the game. It is the responsibility of the coach/captain to make sure he/she has the permission from parents and return the consent form.

7. No weapons of any kind shall be allowed on the event field.
8. HMAAO's Event Committee reserved the right to alter and/or add rules registrations.
9. Proof of ID is required for all players at the time of registration with the application.
10. Any player who receives red card or reject from the field will not be allow to play again on the current tournament.
12. A \$300 safety deposit is required for all sports. The safety deposit will be returned at the closing of the tournament if the team have not violate any fighting rules.

Fighting

1. Any player or team who started a fight will be cautioned and/or expelled from the tournament upon the discretionary of the referees.
2. If more than two players involved in a fight, one or both teams may expelled from the tournament upon the discretionary of the referees.
3. Any individual player or team member who verbally or physically abuses any of the game official will be cautioned and/or expelled from the tournament upon the discretionary of the referees.
4. Any individual player or team member who physically assaults any of the game officials, that individual player or team member will be expelled from the tournament.
5. Any injuries and/or damages caused to others resulting from a fight will be responsible by the individual and/or the team captain that caused it.
6. HMAAO will not be held responsible/liable for any damages and/or injuries occur to any players whether it was accidental or intentional. Players will play at their own RISKS.
7. Any players and/or team that had been expelled from this tournament will **NOT** be allowed to play for the next years.
